




JRC-ENCR QCS 2.1: updates & improvements

Technical improvements:

- Improved architecture: protocol data moved from source code to about 130 configuration files
- Computer memory optimisation during validation
- Improved outputs: more detailed reports & new sections of errors/warnings
- Improved GUI (Graphic User Interface)

JRC-ENCR QCS 2.1: updates & improvements

Checks on single variables:

Ist of variables, allowed format & range of values -> Data Call Protocol 2022

Checks between variables of same record:

> all checks for different combinations of variables

> 6 new checks -> 3 new warnings + 3 new errors

Checks between records:

> more precise filtering criteria for checking MPTs with behaviour<3

> more precise identification & classification of MPTs

JRC-ENCR QCS 2.1: new checks

New errors/warnings:

- > **NEW** consistency check between *morphology* and *grade* for tumours with Beh < 3 (e.g. C50, Urological and CNS tumours): new rule **W-TBGR** (tab.5)*
- > **NEW** consistency checks for *follow-up variables***, *basis of diagnosis* and stage: new rules E-VSBD, E-BDVS and E-AUVS (Tab.10,11 and 12)*
- > **NEW** consistency checks for *stage/treatment variables and other* variables***: new rules **W-SUBD** and **W-SUpT** (p.33)*
- **NEW** classification of MPMTs:
 - **W-MPMT** for tumours in the same patient that should be counted only once for incidence analysis (e.g. C50.1/8500 and C50.3/8520)
 - **W-MPCR** for records that should be revised by CRs before to being • considered for incidence analysis (e.g. C67.9/8130 and C80.9/8000)
