Job vacancy at the JRC: Data analyst 2023-IPR-F1-FGIV-023016

The European Commission's Joint Research Centre (JRC) is looking for an epidemiologist with expertise in information technology for its Cancer Information team, to provide scientific and technical support to the European Cancer Information System (ECIS) and cooperation with the European Network of Cancer Registries (ENCR).

Cancer registration practices in Europe: ENCR-JRC general questionnaire May 2023

This survey will be sent soon to the Directors of the population-based cancer registries operating in Europe with the aim to provide an update on the current practices for cancer registration and the legal framework of the registries. The valuable contribution provided by cancer registries will elucidate on the main challenges European CRs are facing presently, with a view to facilitate future support from the European institutions.

The BENCHISTA project

The International Benchmarking of Childhood Cancer Survival by Stage (BENCHISTA) Project is a research collaboration between multiple population-based cancer registries (PBCRs) within and outside Europe.

The project is designed to understand the reasons of variation in childhood cancer survival rates between countries and to highlight any areas that require improvement. The BENCHISTA Project is currently receiving depersonalised, patient-level datasets including Toronto stage from cancer registries.

A Common Data Quality Check procedure for European Cancer Registries

A new report was recently published by the EC Joint Research Centre in collaboration with the ENCR Steering Committee on Common Data Quality Check procedure for European Cancer Registries. The checks included in this report are implemented in the validation of the data submitted by European Cancer Registries in the 2022 data call to update the European Cancer Information System and will be included in the upcoming new version of the Quality Checks Software.
