CanScreen-ECIS - User Insights Study

CanScreen-ECIS Project (EU4Health programme) is developing and piloting a new screening data management system which is helping improve Cancer Screening across Europe, a key to early cancer detection. CanScreen-ECIS is meant to be integrated into the European Cancer Information System (ECIS).

In this context, a user insights survey was launched as a qualitative study to understand the needs and expectations of the ECIS portal as a repository for data on cancer screening in Europe.

Publication of new long-term estimates for cancer incidence and mortality

The number of people being diagnosed with cancer by 2040 in EU countries plus Norway, Switzerland and Iceland, is predicted to increase by 19% compared to 2022, according to ECIS long-term estimates. The estimates point at population ageing leading to a 27% increase in the number of people dying from cancer by 2040, compared to 2022.

It includes the new QCS 2.1 and the latest version of the CVS Data Layout Converter, the tool used to check the compatibility of the incidence file format with the QCS according to the latest ENCR-JRC call for data protocol.
