Incidence and mortality long-term estimates up to 2040

The ECIS web application includes the long-term national estimates of cancer incidence and mortality for the major cancer types in the EU-27 and EFTA countries (except Lichtenstein), for the period up to the year 2040. These estimates are calculated on the basis of the cancer burden estimates for the year 2020 and the EUROSTAT projected population up to 2040. [More information](#).
